From the Headmaster



In the busy day-to-day life of the School, I continue to enjoy very much all opportunities to meet with Old Vigornians, whether it is at our reunions, as our Barnabas speakers, at careers events, or as individual OVs making personal trips to visit us here in Worcester. It has been wonderful to see the industrious King's Development and Alumni Relations team,

particularly Amanda Sutcliffe, hosting some hugely successful OV events and meeting up with OVs in and outside School, and I am most grateful to them for all their hard work.

I am also very grateful to the Development Trust and to the Trustees for their commitment and their careful stewardship of every donation. The Trust makes a vital contribution to each of our four strategic pillars of Foundation, Sustainability, Futures and Community & Outreach, particularly the last, with its focus on equity, inclusion, and diversity. I thank all the Trustees, who offer their most valuable time and expertise at our termly Trust meetings; I must mention in particular Nick Clark, who has taken up the reins as Trust Chairman, and Hannah Edwards, who has taken over as Chair of the Investment Committee. I would also like to mention Lewis Bryer, who chairs the Nominations Committee; our sincere thanks are also due to Andrew Reekes, who resigned as Chair in April 2022, having offered sterling service in this crucial role. Despite these most challenging times in our national and international economy, our investments continue to be very carefully managed and the bursaries funded thereby remain a fundamental focus for the Trust, providing life-changing opportunities for the young people who benefit in such an extraordinary way from the generosity of others.

The role of the Trust in supporting the King's Bursary Programme cannot be overestimated. I am incredibly grateful to the OVs and Friends of the School who regularly give back to the School and the wider community of Worcester through their support of this programme. Once again, we have been informed of several

legacies to King's that individuals have included within their wills this year, and I would like to extend my sincere thanks to all who choose to remember King's thus. Without the wonderful generosity of all who give to King's in whatever way, we would not be able to continue providing bursarial opportunities for pupils to attend our remarkable School.

We continue to be hugely appreciative of The Kildare Trust for their generosity in offering a further £1m this year to our enduring bursary programme. This will provide two more fully funded places in perpetuity and comes along with their additional grant of £100,000 to provide for any extra costs for children with a bursary, ensuring that all can fully enjoy the opportunities of our extensive co-curricular programme.

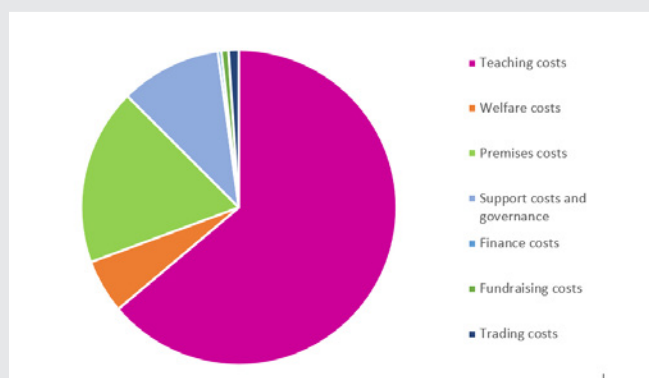

But we must continue to look forward and enhance our provision; by September 2023, the next stage of the development of our Sixth Form will be complete, with a new three-part structure to the curriculum and vast improvements to the accommodation provided for our Sixth Form students in a remodelled School House. This is the first manifestation of our strategic vision for the future of the School over the next 20 years which we shared with the Vigornian community last year.

past 11 years. The Trust has moved forward with remarkable success under his leadership and his drive and focus have been fundamental to that achievement.

There have been several changes in the Alumni Office, and we are most grateful to Amanda Sutcliffe for providing such continuity, calmly and ably managing the Alumni Office in such a positive and efficient way. We offer our sincere thanks to Liz Elliott, who has retired after many years of service, and to Sophie Borrillo-McLellan, who has moved on to pastures new; their warmth and smiles were always greatly received at school and OV functions alike. We also welcome Hannah Sparrey as Head of Alumni and Business Development, who has already made a tremendous contribution to the Development Trust, and we wish her a successful career within our King's community.

In these times of uncertainty and recession, and in the immediate aftermath of the coronavirus pandemic, it might have been expected that our fundraising would have faltered. Instead, we have enjoyed another very successful year. After their previous generosity, The Kildare Trust has gifted the Development Trust a further £1m this year to support our enduring bursary programme; we should not forget that The Kildare Trust was established by OV, James Lawson Richards, which is one of the reasons why their Trustees wished to underwrite two of the School's fully-funded places. Each Kildare Bursary at King's Worcester will provide a child with seven years of education; in addition, the Kildare Trust is providing a further grant of £100,000, which will go towards meeting extra costs for any bursary child. This means that all children with bursaries at the School will have the

potential to enjoy any co-curricular activity or trip, without being restricted by financial means.

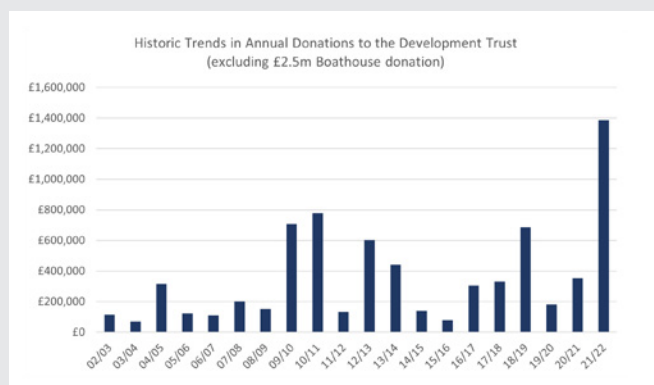
The education of several King's pupils has continued to benefit greatly from the remarkable benevolence of US-based Mark Haworth, as it has from the enduring promise of John Foley to provide annually and in entirety the fees for a bursary pupil. We have also had further substantial donations from David Blundell, among others. The focus of the Trust remains to build up the Bursary Fund, recognising our duty to provide a King's education for talented children from less privileged backgrounds who have so much to offer to and to gain significantly from such a wonderful opportunity. King's has a strong history of providing educational opportunities and we are very proud of this legacy.

Without the efforts of the King's Alumni and Business Development team in maintaining and cultivating links with OVs and friends of the School, I fear these gifts might be much more difficult to find; just as important are the legacies gifted to the School and we must take every opportunity to remind the Vigornian community of the significant impact that their legacy gifts can have on the lives and education of our bursary pupils.

I would like to finish by thanking all my fellow trustees for their commitment and endeavour on behalf of the Trust; my particular thanks go to Lewis Bryer, who, despite only recently joining the trustees, now chairs the newly formed Nominations Committee, and I am also most grateful to Hannah Edwards, who has taken over as Chair of the Investment Committee. We also welcome Bill Ballard to the trustees. Finally, we should recognise those who, having served for a number of years, have decided to step down from the Trust. The continuing success of the Development Trust relies upon the selfless and dedicated stewardship of its trustees as well as the generosity and enthusiasm of all its donors, and we are most grateful to them all.

The past year has shown how active and engaged the OV community is, with the Alumni Team welcoming many OVs back on school visits, as well as receiving their support in various careers and mentoring activities.

After many COVID-cancelled events, it was lovely to have so many OVs in attendance at the

New OV BBQ, the 118th Annual OV Reunion Weekend, and other year group gatherings. As we head into the new academic year, we will continue to rebuild our strong calendar of events, which is so important to the King's Community.

The School remains very grateful for the support provided by OVs, parents and other members of the local community in terms of volunteering, advice, time and financial contributions. The principal fundraising activity for the King's School Development Trust has long been and continues to be for pupil bursaries. In our diverse, dynamic, and developing world, being able to open the door to King's and offer a life-changing education to young people has never been more important. Twelve bursaries were supported during the year to July 2022 through external donations from individuals.

During this academic year the Development Office also launched The King's Ukrainian Fund to raise funds to support the five pupils who had been offered places at the School. In addition, we were very grateful to the Kildare Trust for their generous donations, which will support two fully-funded places from September 2023. Each Kildare Bursary will provide a child with seven years of funded education and these bursaries present a unique opportunity to benefit from everything on offer at King's.

King's has always welcomed pupils from the widest range of social backgrounds. We want to remain a school which any able and aspiring child can attend, regardless of financial circumstances, and to do this we rely on the generous support we receive from so many members of our Foundation community.

Our long-term ambition is to raise sufficient funds to secure the vision which inspired King Henry in his re-founding of the School: forty free places at King's in perpetuity. Focussing on the key date of 1541, whether your donation is £15.41, £154.10 or £1541, it will help to make that vision a reality.

Giving on a regular basis is an affordable way of donating to the Bursary Fund. Regular gifts quickly add up and your contribution will join those of others to fund a bursary place. We also welcome single donations, and all gifts, no matter their size, are gratefully received into the Bursary Fund.

We realise that not everyone will be able to donate to the Bursary Fund in their lifetime. Legacy donations are a meaningful and enduring gift. All bequests, whatever their size, will help to provide access to King's for future generations.

King's really opened the door for me, enabling me to attend Cambridge University; I have no doubt that it provided me with remarkable opportunities and unlocked my academic potential. I might have known that I was academically able, but I never realised just what I would be able to achieve with the help of the School. The wide variety of extra-curricular activities at King's opened my eyes to just what is possible. The CCF and the Duke of Edinburgh's Gold Award were two examples of things that I had never conceived of doing before I came to King's. The King's Bursary Programme, combined with the academic environment of the School, enabled me to achieve my full potential and helped build my character. I can now stand up and say that I am a more well-rounded and shaped individual because of this experience, for which I am so very grateful.

I joined King's in the Sixth Form. At sixteen, it's easy to underestimate how your surroundings can so dramatically shape your sense of what 'people like me' might do. It was revelatory. By the time university applications came around, I remember my House Tutor and my English teacher seeking me out to ask why I hadn't been at the Oxbridge interview preparation class. I hadn't realised it was an option for someone like me.

A few years later, I graduated from Oxford University with a First-Class degree in English Literature. I then spent three years in management consultancy at OC&C Strategy Consultants, went on to lead strategy at the Royal Academy of Arts, and now find myself working every day with the philosopher Alan de Botton at The School of Life. I loved my time at King's but I don't yearn to go back; I'm enjoying where it got me far too much.
